

**SMOKY LAKE COUNTY
IN THE PROVINCE OF ALBERTA
BYLAW NO. 1183-09**

**BEING A BYLAW TO AUTHORIZE THE MUNICIPAL COUNCIL OF
SMOKY LAKE COUNTY, IN THE PROVINCE OF ALBERTA TO
ESTABLISH THE POSITION OF ASSESSOR AS A DESIGNATED
OFFICER.**

WHEREAS, the *Municipal Government Act*, being Chapter M-26 R.S.A. 2000 and amendments thereto, provides that a council may pass a bylaw establishing a position to carry out the powers, duties and functions of a Designated Officer; and

WHEREAS, the *Municipal Government Act*, being Chapter M-26 R.S.A. 2000 and amendments thereto, provides that “Assessor” means a person who has the qualifications set out in the regulation and is appointed by a municipality to the position of designated officer to carry out the duties and responsibilities of an assessor under this Act.

NOW THEREFORE, the Council of Smoky Lake County of the Province of Alberta, duly assembled, enacts as follows:

1. The purpose of this By-Law is to establish the position of Assessor as a Designated Officer of the Municipality.
2. In this By-Law:
 - a) “**Assessor**” means the Assessor for the Municipality and whatever subsequent title may be conferred on that officer by Council or Statute.
 - b) “**Council**” shall mean the Council of Smoky Lake County.
 - c) “**Municipality**” shall mean Smoky Lake County.
3. The position is to be held by a person, body corporate or commission and the powers duties and functions of the Assessor may be exercised by any employee or officer of the body corporate or commission.
4. The powers, duties and function of the Assessor shall be those designated to the Assessor under the provision of the Municipal Government Act, as amended from time to time and any other relative statute for regulation or bylaw making reference to the Assessor.
5. The appointment and terms of the Assessor shall be established from time to time by Council motion.
6. a) That **Accurate Assessment Group Ltd.**, of Sherwood Park, Alberta, employees: **Bob Daudelin, AMAA, Residential Assessment Coordinator** and **Ray Fortin, AMAA, Industrial Assessment Coordinator**, thereof be appointed as the Designated Officers of Smoky Lake County.

- b) That Accurate Assessment Group Ltd. Of Sherwood Park, Alberta, employees **Bob Daudelin, AMAA, Residential Assessment Coordinator** and **Ray Fortin, AMAA, Industrial Assessment Coordinator**, thereof be deemed as independent contractors and not employees of Smoky Lake County.
- 7. This By-law shall remain in full force and effect until such time as it is repealed or amended by a subsequent By-Law.
- 8. That Bylaw No. 1122-05 is hereby repealed

READ a Second Time this 17 day of March, AD 2009.

READ a Third and Final Time this 17 day of March, AD 2009 and finally passed by Council.
