Policy Statement No. 02-22-01: Fireworks Permit Agreement

48-11: Cherniwchan

That **Policy Statement No. 02-22-01** entitled "Fireworks Permit Agreement" be adopted:

Purpose:	To monitor the discharge of Low-Hazard or Consumer Fireworks.
Policy Statement and Guidelines:	
1. STATEMENT:	
1.1	Fireworks are a safety issue that can result in harm to individuals and property.
1.2	Fireworks are primarily regulated under the Alberta Fire Code – Part 5, Section 5.8, which forms part of the <i>Safety Codes Act</i> .

1.3 Within Smoky Lake County, fireworks classified as Low-Hazard or Consumer will be regulated by permit issued by the County Fire Chief.

2. DEFINITIONS

2.1 **Alberta Fire Code:** means the most current version of fire safety regulations adopted by the Province of Alberta and legislated under the *Safety Codes Act*.

2.2 **County Fire Chief:** means the individual who is appointed Fire Chief of the County, or his or her delegate authorized to act in this place as Fire Guardian.

2.3 **Low-Hazard or Consumer Fireworks:** means those types of fireworks which are regulated for storage, sale and discharge under the Alberta Fire Code, but do not require certifications for handling, transporting or discharge. Commonly referred to as Shop Grade or Family Fireworks.

3. GUIDELINES:

3.1 No person shall discharge Low-Hazard or Consumer Fireworks within Smoky Lake County unless he/she holds a valid permit for that purpose issued by the County Fire Chief or his/her delegate as Fire Guardian.

3.2 Valid Permit is the application, as per **Schedule "A": Permit to Display / Discharge Low-Hazard or Consumer Fireworks**, approved by the County Fire Chief or his/her delegate as Fire Guardian.

3.3 Persons who discharge Low-Hazard or Consumer Fireworks within Smoky Lake County must comply with the regulations as stated in the most current version of the Alberta Fire Code.

3.4 Permit issued under this Policy is not transferable.

3.5 Low-Hazard or Consumer Fireworks Permit are required all year round.

3.6 The County Fire Chief may refuse a permit application or cancel any permit. In the event a permit is cancelled, the permit holder shall be notified by the County of the cancellation and the reason for the cancellation, as soon as is practicable.

3.7 Low-Hazard or Consumer Fireworks shall not be discharged during times of fire advisory or fire ban, as **referenced in Bylaw No. 1233-11: Fire Protection Services.**

I have been working on Plan B to have Jane assist with a candidate search.

Community:

- Town of Smoky Lake FCSS is requesting that the County participate in their Welcome Wagon endeavour.
- The Power Alternative is seeking assistance from the Smoky Lake County Agricultural Service Board in organizing producer meetings to explain Bio-diesel production from off-grade canola and Pennycress stinkweed. They are hoping to do 3 producers sessions in early-mid November and would like assistance with locating venues and advertising.
- Smoky Lake Kinsmen Club is requesting to forward all of the unused in-kind work that the County committed to them in the past to their continued work on their pavilion in 2012. Council originally approved \$50,000 of in-kind work and the Kinsmen have used about \$14,000 to date (leaving approximately \$36,000 unaccessed). Normally, this would be a given, since the original motion in 2008 did not put a “sunset” on the contributions, but the Kinsmen were kind enough to send us a request letter.

Present before County Council at 1:10 p.m. to 1:50 p.m. was Karen Henderson, Government of Alberta to provide an update to Council on CRISP: Comprehensive Regional Infrastructure Sustainability Plan on the Cold Lake Oil Sands Area (35 year plan) as follows:

- Process: February to December
 - Opportunities & Constraints Analysis
 - Development Vision and Principles
 - Scenario Development
 - Scenario Evaluation
 - Develop CRISP
- Development between AOSA and CLOSA Areas
 - There is more existing community & infrastructure development within CLOSA.
 - CLOSA is more densely populated.
 - In-situ oil sands development is more evolved in CLOSA.
 - In-situ oil sands development doesn't involve mining, thereby reducing employment needs for extraction.
 - More economic drivers in CLOSA including agriculture, tourism, and CFB Cold Lake.

■ Population & Employment Scenarios for CLOSA – Growth

- Two scenarios and one sensitivity analysis undertaken. Each assumed there would be natural growth rates for the CLOSA (i.e. births and deaths)
- Growths
 - Current Trends (CT) scenario assumed conservative growth estimates for all key industries
 - High Oils Sands Growth (HOSG) scenario assumed high growth rate in oil sands sector, conservative growth for all key industries
 - Sensitivity Analysis assumed high growth in all key economic driver industries. Assumed First Nation communities would experience in-migration back onto reserves of 0.25% per year

■ Population & Employment Scenarios for CLOSA-Bitumen Production

- Assumptions
 - CT and HOSG bitumen production increases to 710,000 bpd from 21 commercial bitumen projects in CERI list identified as in place, under construction or planned
- For CT
 - CLOSA cold production remains steady at current rate of roughly 120,000 bpd per ERCB data
 - Overall bitumen production increases until 2003, remains steady to end of projection period (2045)
- For HOSG
 - 110,000 bpd bitumen production from projects not currently planned
 - Cold production increases at 205% annual growth to reach 190,000 bpd by 2045
 - New bitumen upgrader is built with capacity of just over 200,000 bpd

■ CLOSA Public Open Houses

- Allowed the community an opportunity to provide feedback on proposed growth and infrastructure scenarios
- Held in Bonnyville (September 20), Cold Lake (September 21) and St. Paul (September 22)
- General feedback included:
 - Need to ensure water quality and quantity
 - Addressing transportation issues (air, road, bus)
 - Realizing regional economic potential
- Not always consistent feedback on how issues should be handled

■ Scenario Evaluation – Conclusions

- Population growth in CLOSA expected to be typical of other Alberta regions

- Even under high bitumen production scenario oil sands related growth represents small proportion of overall population growth
- Majority of growth is expected to be an urban/rural mix in Cold Lake – Bonnyville corridor
- Work camp accommodations not preferred means of housing for majority of oil sands companies
- Communities in southern portion of CLOSA are less impacted by oil sands development
- Additional school / hospital capacity will be required at a rate typical for other regions in the province
- Growth requires additional water / wastewater servicing capacity
- High potential for regional water servicing; benefits for regional wastewater servicing is less significant
- Road network appears to sufficient in terms of capacity and coverage with some localized exceptions
- Growth in oils sands could justify enhanced bus-based transit service for oil sands commuters
- Enhanced airport capacity does not appear to be strongly needed from an oil sands development perspective
- Additional pipeline & utility capacity needed
- As with other municipalities in Alberta, addressing existing infrastructure gap is key concern
